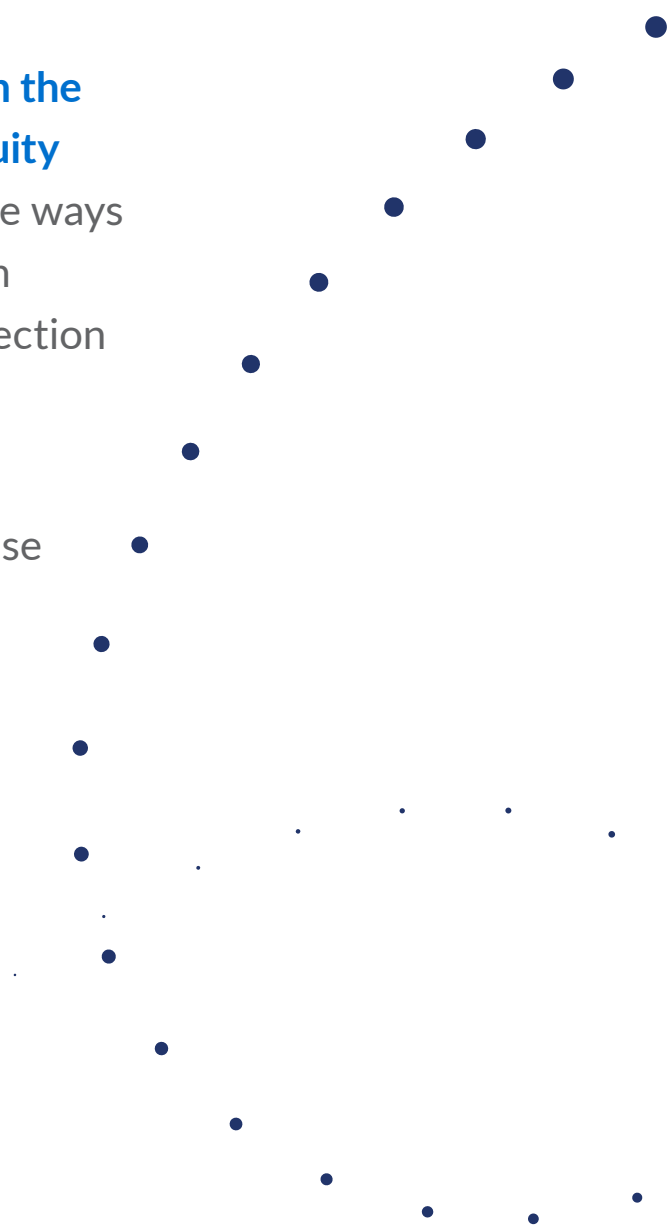


AssuranceSelect 7 Plus Renewal History
