Charts show the initial declared rates and indexed strategy caps and participation rates for terms that started in the fourth quarter and on the 6<sup>th</sup> and 20<sup>th</sup> of each month in years 2020-2023 (Chart Terms) and the corresponding declared rates, caps and participation rates when the terms renewed in years 2021-2024. Although the charts show the caps/maximum indexed interest rate for each strategy for each Chart Term, they do not show the indexed interest rate for any strategy for any Chart Term, which may be less than the cap.
