We do not guarantee that amounts allocated to an indexed strategy will earn interest, but the indexed interest rate for a term year will never be less than 0%.

Early withdrawal charges and a market value adjustment apply if you surrender your annuity or take withdrawals from it during the first seven contract years. Early withdrawal charges and market value adjustments do not apply to amounts covered by the 10% free withdrawal allowance. Withdrawals, early withdrawal charges and market value adjustments impact contract values and benefits. The amount payable to you if you surrender your contract will never be less than the Guaranteed Minimum Surrender Value.

The contract offers life payout options. If you select one of these options, we will make periodic payments until the death of the person on whose life payments are based. After the annuity payout initiation date, you cannot surrender your annuity or withdraw any other money from your annuity.

In general you will pay ordinary income taxes on the earned interest when you receive annuity payout benefits, you surrender your annuity or you take a withdrawal. You may pay a 10% federal penalty tax on the taxable amount of any payment that you receive before age 59½.
