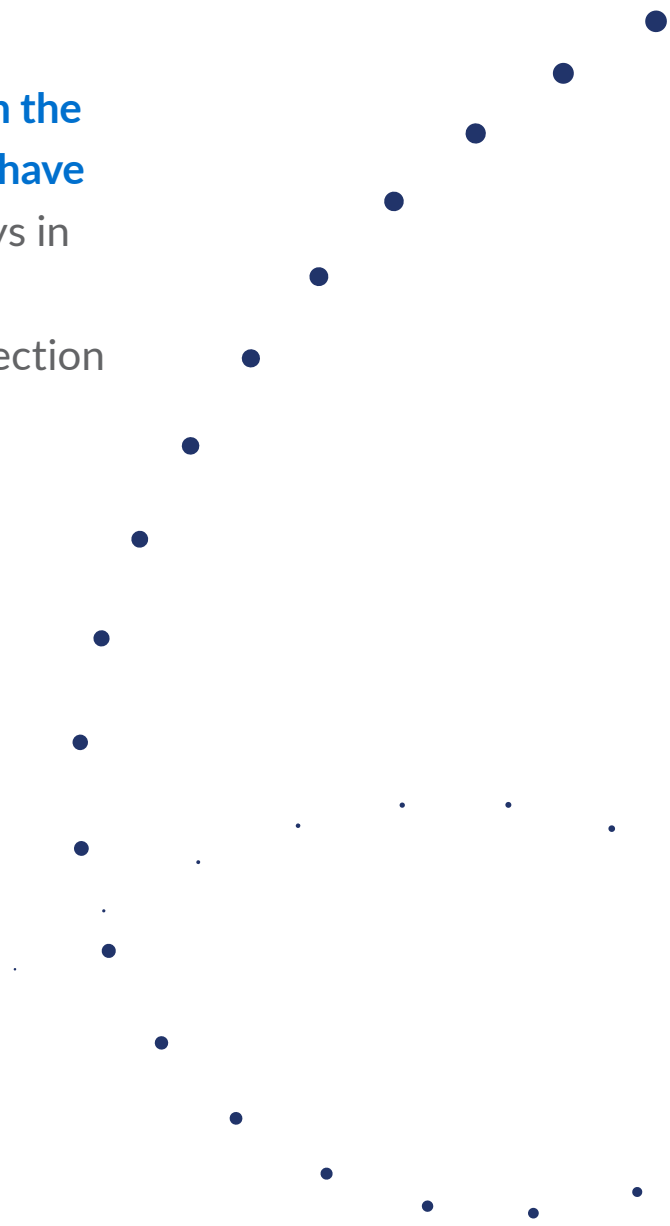


American Legend 7 Renewal History from MassMutual Ascend Life Insurance Company
