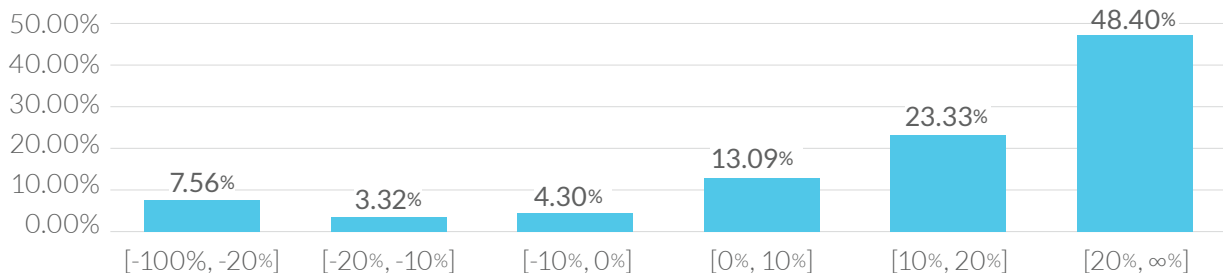
S&P 500 returns using rolling periods

The data below uses 2-year rolling returns¹ of the S&P 500 price return index (SPX) from December 31, 2004 through December 31, 2024, for a total of 4,698² observations.

S&P 500 return distribution

Using the same data set and assumptions, the return distribution graph below illustrates how frequently the 2-year returns fell into specific ranges. The table below the graph shows the average return by range.
