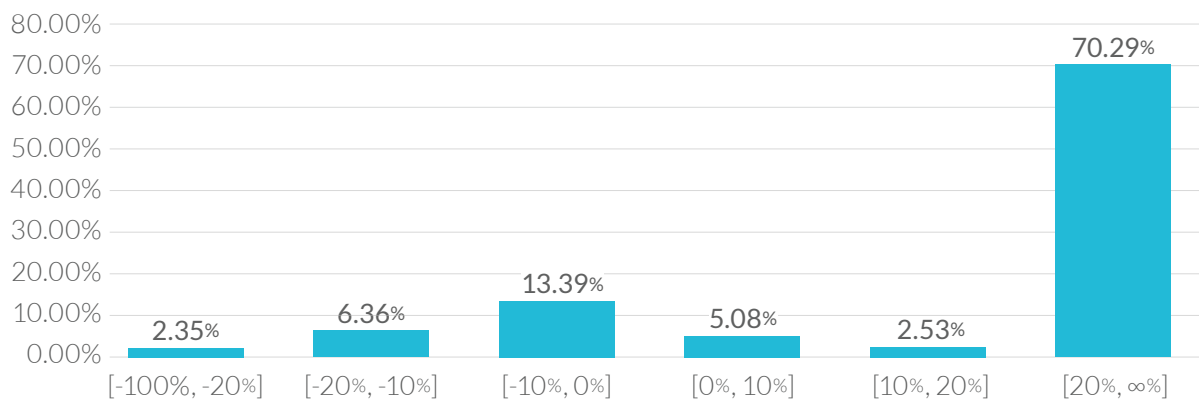
## S&P 500 returns using rolling periods

The data below uses 5-year rolling returns<sup>1</sup> of the S&P 500 price return index (SPX) from December 31, 2003 through December 31, 2023, for a total of 3,914<sup>2</sup> observations.

## S&P 500 return distribution

Using the same data set and assumptions, the return distribution graph below illustrates how frequently the 5-year returns fell into specific ranges. The table below the graph shows the average return by range.
