These caps and upside participation rates may vary from term to term. For current strategies, the cap for a term will never be less than 1% and the upside participation rate for a term will never be less than 5%. Future indexed strategies could offer different minimum caps and participation rates. For each indexed strategy that we currently offer, any negative return for a term is limited by a 50% downside participation rate, a -10% or 0% floor, or a 10% buffer. Future indexed strategies could offer different downside participation rates, floors, and buffers.
